LICENCE TO PUBLISH TERMS

- In consideration of the Proprietor evaluating the Contribution for publication (and publishing the Contribution if the Proprietor so decides) the Author(s) grant to the Proprietor for the full term of copyright and any extensions thereto, subject to clause 2 below, the right and irrevocable licence:
 - to edit, adapt, publish, reproduce, distribute, display and store the Contribution in all forms, formats and media whether now known or hereafter developed (including without limitation in print, digital and electronic form) throughout the world;
